Financial Report

The Division currently has the following funds as of the April 30. 2020 Union Bank statements:

Savings	\$5,102.89
Total	\$19,282.62

Available funds are expected to be reduced due to the canceling of the Van Nuys Local 2020 Convention. This is due to transferring registrations over to the PSR 2021 Orange Blossom Special Convention as well as issuing refunds for registrations, Hobo breakfast, tours and extra fare clinics.

Storage Unit for Division Supplies

Discussion regarding the storage of L. A. Division supplies that are currently kept as various members homes. It was suggested that a storage unit be looked into for centralizing the Divisions' assets, which includes projectors, screens, sound system, banner and display stands. Due to the large amount of plastic models intended for Hobo Auctions, Raffles and Door Prizes, a climate control air conditioned storage unit is mandatory.

Based upon preliminary investigation, the cost of storage units are within the following ranges:

5' x 5'	\$65 to \$70/Month	Estimated cost per year up to	\$840.00
5' x 10'	\$105 to \$110/Month	Estimated cost per year up to	\$1,320.00

Based upon the amount of items that the Division has, a 5' x 10' storage unit would be the most desired. Mona Raymer will do a more thorough search for units that meet the Division's needs and is also somewhat centrally located then report back to the Advisory Board.

Great Train Show

The Los Angeles County Fairplex has canceled all events through the end of September, which has canceled Great Train Show that was to be held weekend of August 8 - 9, 2020.

Non Profit Status

The Pacific Southwest Region is still proceeding with the filing of 501-C-3 status for the overall Region, which includes all for the four of the Divisions.

NMRA at Risk Policy

Discussion regarding the new "At Rick Policy" of the NMRA and how it will affect our future sponsored and co-sponsored events. We have two upcoming events this year, which are:

December 4 – 6, 2020	South Coast Botanical	Frosty Freight

Both events are not directed at individuals under the age of 18 that are classified at risk. The Prototype modelers meet is attended by adult model railroaders. Jeff Smith of RailMaster Hobbies is the main sponsor of the event with the L. A. Division being a co-sponsored for NMRA insurance purposes.

The South Coast Botanical Gardens show is held a Los Angeles County facility, which is open for the general public and anyone under the age of 18 is required to be accompanied by a parent or adult guardian. The L. A. Division does not charge a fee to the general public for attending this event. Entrance is obtain by attendees paying admission to Los Angeles County to enter the Gardens.
